PUBLIC HEARING

The Board of Supervisors of Salem Township will conduct a public hearing on Monday, December 8, 2025, at 6:00 p.m. at the Salem Township Administration Building, 38 Bomboy Lane, Berwick, Pennsylvania, to consider and possibly take action on an application from Dorthy Dee Partner (Trevor Hanson) for a proposed zoning map amendment to create an SDC-O Special Data Center Overlay District. The SDC-O Special Data Center Overlay District allows a controlled development of a Data Center Campus through a Master Plan process. The Master Plan process allows for planned development of the full campus over a period of time in a manner that presently does not exist under the current Salem Township Zoning Ordinance.
